#### **MEETING MINUTES**

#### I. Call to Order:

The meeting was called to order by Chair, Maggie Massengale at 4:30 p.m.

- 1) **Declaration of Quorum:** A quorum was declared (3/5)
- 2) Note absentees: Francis, Mary and Bonnie indicated previously that they could not attend the meeting.
- 3) Approve minutes of the January 2012 meeting: No meeting held due to snow storm and school cancellation.
- **4) Approve minutes of the December 8, 2011 meeting:** On motion by Sandra O'Farrell and second by Maggie Massengale, the December 8, 2011, minutes were unanimously approved.

#### II. Report on Operations Work

- 1) Maintenance: Icy driveways and parking lots discussed;
- 2) **Food Service:** Continues to operate smoothly with success for fresh fruits and vegetables;
- **3) Transportation:** The Transfinder program is almost complete with two routes left to be entered. Bus routes will be easier to generate with this program
- III. Discuss the drainage issue at Union Elementary School: Scott Wyman and Susan Pratt reported that the drainage issue at the Union Elementary School was being looked at as reported in other Board meetings. The recent estimate to fix the problem is \$32,000.00. Department of Transportation (DOE) has a drainage easement across the sports field in the front of the building, bordering Route 17.
