- **I.** Call to Order The meeting was called to order at 1:05 p.m. by Chair Wooster.

III. Financial Report

- a. Karla reviewed the financials with the committee going over budget lines that were overdrawn.

 - iii. Facilities and Maintenance due to the maintenance projects and paving that are being completed this summer
- b. Food Service Financials were discussed.
