III. Financial Report

a. There were questions on School Nutrition receipts as there were none reported and Karla explained that the Business Office is one person down and we are a little behind.

IV. Budget Cap Recommendation for Administrators – FY 2015

a. Mike shared with the Committee that with teacher negotiations behind us, the work that the Facilities Committee is doing and wanting to add Pre-Kindergarten to the budget next year, it would seem reasonable to expect an increase in the budget.

Upon a motion by Ann Donaldson and second by Lynda Letteney, the committee voted to recommend to the full board a budget cap of no more than 3-1/2% with the understanding that Administration should try and have the proposed budget be less than 3-1/2%. Vote: 5-0

V. Other

- **a.** Dennis Wooster informed the Committee that the Waldoboro SRO had resigned. He also asked if we pay per diem as the Chief will be filling in half days until a new person is assigned. Karla responded that we do pay per diem and it would be pro-rated while the Chief is working half-days.
- **b.** Linda Letteney asked if any of the buses had underneath storage capabilities for travelling with bands and sports equipment? Karla will check with George and get back to the

Committee. Dennis thought that at least one of the buses, if not two, had underneath storage.
