  - i. Sara asked if the cost sharing formula went out for renewal every ten years and when would the ten years be up? Karla distributed the cost sharing formula from the Department of Education. It was discussed that the cost sharing formula is a private and special law with an alternate cost sharing plan: 50% based on State valuation and 50% based on number of pupils. The cost sharing plan does not come up for renewal but could be modified through the legislature.
