They will be for one year. The principal and superintendent will discuss as the committee recommended allowing flexibility.

The committee was informed on the resignation of Bob England. Kate Race had arrived at the meeting and the process for hiring was discussed. Discussion about the ad whether to be a one year position or a regular position was discussed.
